



Thomas Arnold, CTA is a commercial barrister who specialises in tax law. He is regularly retained by taxpavers. professional advisors, the Commissioner of Taxation and the Tax Practitioner's Board. He has been briefed to advise and appear in a broad range of tax matters. His advisory practice involves assisting taxpayers with developing audit strategies, responding to requests for information, claims for legal professional privilege and challenges to compulsive notices. He holds a Masters of Tax Law from the University of Sydney and a Chartered Tax Advisor qualification from the Tax Institute. He is a member of the Tax Institute's Dispute Resolution Committee.

Chris Atkinson is a Partner of Deloitte Australia and Legal Practitioner Director of Deloitte Legal. Chris specialises in tax controversy where he has successfully acted for a range of high-profile clients in respect of ATO audit activity and formal taxation disputes. This includes helping clients to navigate the challenges of tax audits and risk reviews, objecting against assessments, pursuing alternative dispute resolution, negotiating settlements, right through to appealing to the AAT, Federal Court and Full Federal Court. Chris also has significant experience advising clients on the taxation implications of a range of transactions for some of Australia's wealthiest groups, inbound investors and ASX 20, 50 and 100 entities.

Damien Browne is an Assistant Commissioner in ATO Review and Dispute Resolution, which is responsible for ATO dispute resolution policy and practices, including running the Independent Review service, handling all objections and managing ATO litigation. Increasingly, the ATO is using alternative dispute resolution to better resolve and manage disputes. Damien joined the ATO in 2007 from the Commonwealth Ombudsman's office, where he was variously responsible for information technology, public and international affairs, public contact, and the Taxation and Defence Force Ombudsman roles. He was responsible for the ATO's public advice policy, National Practice Manager for legal services, and the ATO's Individuals Objections teams prior to taking on his current role.

Kate Carnell AO is the Australian Small Business and Family Enterprise Ombudsman (ASBFEO). The role of the ASBFEO is to advocate for small businesses and family enterprises, to provide access to alternate dispute resolution services to assist in avoiding expensive legal proceedings, and to ensure that government policies and regulations take into account the needs of small businesses and family enterprises. Kate is well known and respected in the not-for-profit and business communities having served as CEO of the Australian Chamber of Commerce and Industry, beyondblue and the Australian Food and Grocerv Council. Kate also served as Chief Minister of the ACT from 1995 to 2000 and was appointed Officer of the Order of Australia in 2006.

Vivek Chaudhary is the Deputy Commissioner of Debt and Lodgment at the Australian Taxation Office. Vivek has 20 years of global financial services experience transforming and growing business teams into highly productive operations. He previously worked at NAB and was responsible for transforming its collections function into NAB Assist making NAB the first Australian company to make the Fortune's Change the world list in 2016. Prior to joining the ATO, Vivek partnered in NAB's Financial Crime Operations to establish a world-class capability across NAB's entire network to reduce exposure from money laundering, terrorist financing, tax evasion, bribery and corruption. Vivek is also a founding director and board member of 'Way Forward Debt Solutions', which is a not-for-profit organisation that provides a free service to clients who are in financial difficulty, assisting them on a path to financial stability.

Michael Cosgrove is a barrister at the New South Wales Bar. Michael primarily practises in taxation law, particularly federal taxation law. Michael has around 12 and a half years of experience that is primarily in tax, including almost 5 years as a barrister practising from New Chambers. Tim Dyce is the Deputy Commissioner for Private Wealth. Tim was appointed as a Deputy Commissioner in 2006 following a long and established career in the ATO. Having held senior leadership roles in a number of business lines including Income Tax, Aggressive Tax Planning and Indirect Taxes (GST and Excise) Tim has extensive experience in taxation administration. Drawing on this experience Tim is an active and influential contributor to various internal and external committees and forums that shape the Client Experience for Not for Profit entities, Excise entities and Private Groups. Ultimately, Tim has national responsibility for the willing participation and voluntary compliance of private groups and high wealth individuals in Australia. Jeremy Geale, CTA, is the Deputy Commissioner for Review and Dispute Resolution, an independent area within the ATO responsible for the ATO's approach to dispute resolution for all taxpayers. Recently Chris was heavily involved with the Chevron transfer pricing case having represented the Commissioner in that case. Chris is the co-chair of the Tax Institute's Dispute Resolution Committee and the chair of the Number One Tax Discussion Group. Chris is accredited in dispute resolution with the NSW Law Society.

Chris Peadon has practised at the NSW Bar since 2011 and previously worked as a solicitor for a decade. He regularly advises and appears for taxpayers and the Commissioner.

Renata Saini is a Managing Associate of Deloitte Legal. Renata specialises in tax controversy where she provides legal and strategic advice in relation to the resolution of taxation disputes at various stages, ranging from commencement of risk reviews and audits by the ATO, Objecting against Assessments, discussing settlement options or alternative dispute resolution, through to appealing to the AAT, Federal Court and Full Federal Court. Renata has over 18 years' experience advising multinationals and private clients on taxation matters across a broad range of industries. Early in her career Renata spent 5 years with the Australian Government Solicitor litigating on behalf of the Commissioner of Taxation.

Andrew Sommer, CTA, is the national practice group leader for tax at Clayton Utz and has been working in tax for over 25 years. Andrew specialises in GST, providing advice across all industry sectors and levels of government as well advising on other tax issues, including land tax, payroll tax, FBT and statebased royalty regimes.
