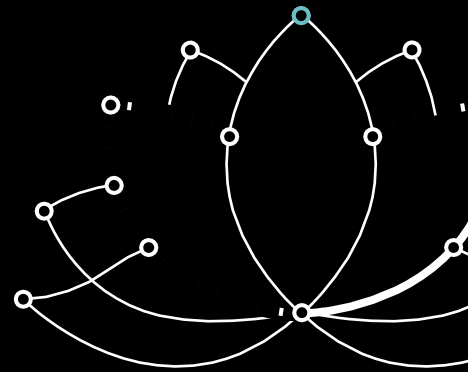


Beyond Resilience – Lessons from High Performance Coaching
